Attachment B: The Initial Interviews

Investigator: If you can think of anything else, please let us know.

The Rival: Max

The Investigator: Can you state your name and age please?

Max: Max Stanton, 16 years old.

The Investigator: Can you tell us what happened during and after practice?

Max: It was a typical sprinters workout. We ran some laps, did our active stretching and did our sprint routine based on the events we run. Then we do our cool down and head back to the locker room to shower and change. Ryan said his backpack was stolen and the cops came.

The Investigator: You don't all do the same routine.

Max: No. The students who run the 55m and the 100m do one routine and the ones who do the 200m and the 400m do a different routine.

The Investigator: What if you run more than one event?

Max: You can pick which routine you do. Most students would alternate, but Ryan does a hybrid. He usually starts with the shorter routine and ends with the longer one. The coach basically lets Ryan do whatever he wants.

The Investigator: Are you jealous of Ryan?

The Investigator: Did you find it?


Coach: Yeah, it was in my car.

Fingerprints found at the scene










Prints of the Persons of Interest

Max


Investigator: Can you explain how your fingerprints got on Ryan's locker?

Investigator: Did you go into the locker room during practice?


Coach: I might have, but I don't remember going in there.

The police then called Max and Derek back in for further questioning.


Investigator: Can you tell me how you cut your hand?

Max: I cut my hand in woodshop today. It happens all the time.


Investigator: Can you tell me how you cut your hand?

Derek: I walked by a chain link fence and my hand was going along it. Part of the fence was broken and I didn't notice until I cut my hand.


DNA found on hair outside of locker




Partial DNA of Coach
